- A civil penalty imposed for a civil traffic violation shall not exceed \$250.00, plus surcharges, except as otherwise provided by statute.
- A civil penalty imposed on a juvenile for a civil traffic violation shall be the same as a civil penalty imposed on an adult.
- A penalty imposed on a juvenile offender for a criminal traffic violation shall not exceed \$150.00, plus surcharges, unless a greater amount is provided by statute (but not to exceed \$500.00).
- A fine or penalty imposed for a class 1 misdemeanor shall not exceed \$2500.00, plus surcharges.
- A fine or penalty imposed for a class 2 misdemeanor shall not exceed \$750.00, plus surcharges.
- A fine or penalty imposed for a class 3 misdemeanor shall not exceed \$500.00, plus surcharges.
- A fine or penalty imposed for a petty offense shall not exceed \$300.00, plus surcharges.

(or, on defendant's ability to pay, which amount could be less)

- **The court shall not waive any portion of the fine, additional assessment or surcharge on a DUI, Extreme DUI, Aircraft DUI or Boating DUI (effective 3/13/2004).**
