Michael T. Liburdi United States District Judge District of Arizona

United States District Judge Michael T. Liburdi began his legal career as a law clerk to the Honorable Ruth V. McGregor of the Arizona Supreme Court.

He entered private practice with the law firm of Brown & Bain P.A., which became the Phoenix office of Perkins Coie LLP. He later practiced at Snell & Wilmer L.L.P.

From 2015-2018, Judge Liburdi served as General Counsel to Arizona Governor Douglas A. Ducey. Judge Liburdi provided legal advice to the Governor, advised on appointments to the state judiciary, directed litigation involving the state agencies, and worked with Arizona's Congressional delegation on legal policy issues.

Immediately prior to his judicial appointment, Judge Liburdi was a shareholder at the international law firm of Greenberg Traurig, LLP.

Judge Liburdi's private sector practice included complex commercial litigation, antitrust, constitutional law, and political and election law.

Judge Liburdi has served as an adjunct professor of law at the Sandra Day O'Connor College of Law at Arizona State University.

Judge Liburdi earned his Juris Doctorate from the Sandra Day O'Connor College of Law and a Bachelor of Science degree from Arizona State University.

Jodie graduated from the Sandra Day O'Connor College of Law at Arizona State University in 2005. During law school, Jodie served as a legal extern to Judge Lawrence O. Patricia (Pat) Gerrich was previously the Director of the Volunteer Lawyers Program (VLP) and currently works with VLP to provide staff support for the Free Advice Only Clinic that arranges pro bono guidance for unrepresented non-incarcerated civil litigants in the Phoenix District Court. The Volunteer Lawyers Program (VLP) is co-sponsored by Community Legal Services, the "legal aid" organization for 5 counties in Arizona, and the Maricopa County Bar Association.

As VLP Director, Pat supervised staff advocates and worked with private lawyers who volunteered their time to provide legal advice or representation to people with low incomes in Maricopa County, to supplement the work of legal aid staff. The volunteer attorneys addressed civil legal issues such as consumer, bankruptcy, children's issues, debt collection, domestic violence/family law, guardianship, home ownership, tenants' rights, tort defense, and transactional assistance to non-profit organizations.

Pat previously was Executive Director of The Arc of Arizona for 7 years where she supervised advocates and was responsive for legislative advocacy on behalf of individuals with disabilities. She also served as staff attorney for 3 ½ years for the Arizona Center for Law in the Public Interest where she participated in litigation and other advocacy to benefit children with disabilities, people with mental health needs, and seniors. Pat received her J.D. from Arizona State University College of Law.

Loresa Purden Arizona Department of Corrections Legal Monitor

Loresa Purden has worked with law enforcement for over 20 years. She is currently the Legal Access Monitor for the Arizona Department of Corrections, Rehabilitation and Reentry. She ensures that inmates have adequate and constitutional access to the courts. Using case law, such as Lewis v. Casey, 518 U.S. 343, 116 S.Ct 2174 (1996), relevant statues, and agency policy as her guides, Ms. Purden is responsible for establishing appropriate measures for inmates to proceed with habeas corpus cases and other matters, unencumbered. She also supervises the contract paralegal responsible for assisting inmates in a limited capacity, on qualified legal claims as outlined by policy.
